ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1.

Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the B3-1, Community Shopping District symbols as shown on Map No. 11-M in the area bounded by:

The public alley next north of and parallel to West Irving Park Road; a line 66.44 feet east of and parallel to North Mason Avenue; West Irving Park Road; and North Mason Avenue.

To those of a B2-2, Neighborhood Mixed-Use District
