ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1.

Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the B1-2, Neighborhood Shopping District symbols as shown on Map No. 2-G in the area bounded by:

West Taylor Street; South Carpenter Street; the public alley next south of and parallel to West Taylor Street; and a line 53.59 feet west of and parallel to South Carpenter Street.

To those of a B3-3, Community Shopping District

SECTION 2. This Ordinance takes effect after its passage and due publication.
