#### **ORDINANCE**

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the Cl-3, Neighborhood Commercial District symbols and indications as shown on Map No. 8-F in an area described as:

West 31st Street; a line 62.5 feet east of and parallel to South Princeton Avenue; a line 100 feet south of

and parallel to West 31<sup>st</sup> Street; and a line 28.0 feet east of and parallel to south Princeton Avenue

to those of a B2-3, Neighborhood Mixed-Use District.

SECTION 2. This ordinance takes effect after its passage and due publication.
