# **ORDINANCE**

# BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION I. Title 17 of the Municipal Code, the Chicago Zoning Ordinance,

be amended by changing all the Bl-1 Neighborhood Shopping District symbols and

indications as shown on Map No. 18-K in the area bounded by

a line 88.72' north of and parallel to West 78<sup>th</sup> Street; the public alley next east of and parallel to South Cicero Avenue; West 78<sup>th</sup> Street; and South Cicero Avenue;

to those of a B3-1 Community Shopping District is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
