ORDINANCE
JEWEL FOOD STORE #3345 Acct. No. 259
- 42 Permit No. 1142982

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to JEWEL FOOD STORE # 3345, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, one (1) Occupation of Space(s) on the public right-of-way adjacent to its premises known as 1224 S. Wabash Ave..

Said Occupation of Space(s) at Public Alley between South State Street & South Wabash Avenue measure(s): Approximately one (1) at one hundred seventy (170) feet in length, and thirty-four point two five (34.25) feet in width for a total of five thousand eight hundred twenty-two point five (5822.5) square feet. Said occupation of space shall be used for customers and employees parking.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development, Department of Transportation (Division of Project Development), and Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation forthe privilege #1142982 herein granted the sum of seventeen thousand eight hundred seventeen (\$17,817.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.
