ORDINANCE

Be it Ordained by the City Council of the City of Chicago:

SECTION 1. That the Chicago Zoning Ordinance be amended by changing all of the current B3-3, Community Shopping District symbols and indications as shown on Map Number 7-1 in the area bounded by:

West Logan Boulevard; a line 204.4 feet east of the intersection of West Logan Boulevard and north Milwaukee Avenue as measured along and perpendicular to West Logan Boulevard; a line 204.4 feet southeast of the intersection of West Logan Boulevard and North Milwaukee Avenue as measured along and perpendicular to North Milwaukee Avenue; North Milwaukee Avenue; a line 154.4 feet southeast of the intersection of West Logan Boulevard and North Milwaukee Avenue as measured along and perpendicular to North Milwaukee Avenue as measured along and perpendicular to West Logan Boulevard and North Milwaukee Avenue as measured along and perpendicular to West Logan Boulevard,

To those of a C2-3 Motor Vehicle Related Commercial District.

SECTION 2. This ordinance shall be in full force and effect from and after its passage and due publication.

In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107. please be informed that on or about January 8, 2020 the undersigned will file an application for a change in zoning from a B3-3 Community Shopping District to a C2-3 Motor Vehicle-Related Commercial District for the property located at 2551 North Milwaukee Avenue/3061 West Logan Boulevard.

The purpose of the zoning amendment is to allow the applicant to pursue a special use for an adult use cannabis dispensary at the above location. If the zoning amendment is approved, the applicant will file an application for a special use. Upon receipt ofthe necessary approvals, the applicant will remodel an approximately 3,350 sq. ft. first floor retail space fronting on Milwaukee Avenue and approximately 1,000 s.f. basement space for a cannabis business establishment. No other modifications to the 3-story building or existing uses are planned.






