ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO.

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the CI-2 Neighborhood Commercial District symbols and indications as shown on Map No. 9-H in the area bounded by

A line 324.35 feet South of and parallel to West Grace Street; North Ashland Avenue; a line 349.35 feet South of and parallel to West Grace Street; and the alley west of and parallel to North Ashland Avenue.

to those of a B2-3 Neighborhood Mixed-Use District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
