### SUBSTITUTE ORDINANCE

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

**SECTION 1. The Chicago Zoning Ordinance, be amended by changing all of the C2-2, Neighborhood Commercial District symbols and indications as shown on Map No. 8-G in the area bound by:**

~~South Lituanica Avenue; a line 30 feet north of and parallel to West 35<sup>th</sup> Street; the alley next east of and parallel to South Lituanica Avenue; the alley next north of and parallel to West 35<sup>th</sup> Street; a line 58.7 feet east of South Lituanica Avenue; the alley next south of West 35<sup>th</sup> Street; a line 49 feet west of south Lituanica Avenue; West 35<sup>th</sup> Street; a line 149 feet west of South Lituanica Avenue; the alley next south of West 35<sup>th</sup> Street; a line 199 feet west of South Lituanica Avenue; and West 35<sup>th</sup> Street. the alley next west of and parallel to South Halsted Street; West 35<sup>m</sup> Street; the alley next west of and parallel to South Halsted Street; the alley next south of and parallel to West 35<sup>th</sup> Street; South Sangamon Street; and West 35<sup>te</sup> Street.~~

**to those of an B1-1, Neighborhood Shopping District.**

**SECTION 2. This ordinance shall be effective after its passage and publication.**

**SECTION 3. The Chicago Zoning Ordinance, be amended by changing all of the C2-2, Neighborhood Commercial District symbols and indications as shown on Map No. 8-G in the area bound by:**

West 35<sup>th</sup> Street; a line 151 feet east of South Lituanica Avenue; the alley next north of and parallel to West 35<sup>th</sup> Street; and the alley next west of and parallel to South Halsted Street.

**to those of an B1-1, Neighborhood Shopping District.**

**SECTION 4. This ordinance shall be effective after its passage and publication.**

**SECTION 5. The Chicago Zoning Ordinance, be amended by changing all of the C2-2, Neighborhood Commercial District symbols and indications as shown on Map No. 8-G in the area bound by:**

West 35<sup>th</sup> Street; a line 150 feet east of South Sangamon Street; the alley next south of and parallel to West 35<sup>th</sup> Street; and South Sangamon Street.

**to those of an B1-1, Neighborhood Shopping District.**

**SECTION 6. This ordinance shall be effective after its passage and publication.**
