BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the Ml-2, Limited Manufacturing/Business Park District symbols and indications as shown on Map No. 18-E in the area bounded by

East 74th Street; the alley next east of and parallel to South State Street; a line 200 feet south of and parallel to East 74th Street; and South State Street

to those of a M2-2 Light Industry District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

The applicant intends to use the designated property for a one story cannabis business establishment with zero residential units, and with 18 proposed on-site parking spaces. The building is existing and will remain approximately 11,435 square feet of space and 31 feet 1 inch in height.

Bookmark 17-13-0107-A Written Notice. Whenever the provisions of this Zoning Ordinance require that "Written Notice" be provided, such notice must be given as specified in this section.

- 1. Timing.
- a) One written notice of administrative adjustment applications must be provided by the applicant at least 10 days before the Zoning Administrator takes action on the application. The Zoning Administrator may not take final action on an administrative adjustment application until at least 10 days after the date that notices were mailed to abutting property owners as well as the Alderman of the ward in which the administrative adjustment is proposed.
- b) One written notice for all other applications requiring written notice must be provided by the applicant no more than 30 days before filing the application.
- 2. Radius. Unless otherwise expressly stated, the notification radius for applications requiring written notice is as follows:
- a) In the case of special use applications and zoning map amendments, including planned developments, written notice must be provided to property owners of the subject property and to all property owners within 250 feet of the property lines of the subject property.
- b) In the case of special use applications for sanitary landfills, hazardous waste treatment or storage facilities, liquid waste handling facilities, resource recovery facilities, reprocessable construction/ demolition material facilities, incinerators or transfer stations, the applicant must provide written notice to all property owners within 500 feet of the property lines of the subject property.
- c) In the case of administrative adjustment applications, the applicant must provide written notice to property owners of abutting lots on both sides of the subject property.
- d) In the case of variation applications, written notice must be provided to pioperty owners of the subject property and to all property owners within 100 feet of the property lines of the subject property.
- e) Land occupied by public roads, streets, alleys and other public ways is to be excluded in computing the required notification radius.

- d) When any property in the area requiring notice has been converted to condominiums pursuant to the "Illinois Condominium Act" and contains more than 25 condominium units, notice must be given only to the Condominium Association governing the pioperty.
 - 9. In the case of special use and variation applications, the Zoning Board of Appeals must send written notice to those persons required to be notified under paragraph 17-13-0107-A2, above.


