ORDINANCE

5£ JT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION I. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the B1-2 Neighborhood Shopping District symbols and indications as shown on Map No. 15-G in the area bounded by

a line 90.0 feet north of and parallel to West Thorndale Avenue; North Broadway Street; a line 40.0 feet north or and parallel to West Thorndale Avenue; and the alley next west of and parallel to North Broadway Street,

to those of an B3-2 Community Shopping District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.




