ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 ofthe Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all ofthe RS-3 Residential Single Unit (Detached House) District symbols and indications as shown on Map No. 16-E in the area bounded by

A line 300 feet north of and parallel to East 69th Street; South Michigan Avenue; a line 275 feet north of and parallel to east 69th Street; and the alley next west of and parallel to South Michigan Avenue

to those of a RT-3.5 Residential Two Flat, Townhouse and Multi-Unit District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.


