Dear Mr. Flessner:

Pursuant to a request from Mr. David Pinkerton, we are transmitting herewith for your review and approval as to form and legality an original and three (3) copies of a proposed vacation of a street remnant along the northern periphery of W. Pershing Road between S. Halsted Street and S. Emerald Avenue. This property is located in the 11th Ward.

Lakeside Bank is the successor owner of property, as auctioned and sold by the Department of General Services in 2018. The portion sold however was public way, which has resulted in a cloud upon the title. As such, both the owner and the Department of Transportation wish to officially vacate the area, in order to clear confusion regarding the status of the land. The people to contact in connection with this proposed ordinance are Attorney Paul Kolpak at 847-647-0336, and Mr. David Pinkerton at 312-435-1631.

Section 2 of the ordinance reserves a blanket easement for any utility currently existing within the area to be vacated. Section 3 provides indemnification language. Sections 4 and 5 include standard recording and other language regarding the ordinance.

### COMMERCIAL VACATION ORDINANCE

WHEREAS, the City of Chicago ("City") is a home rule unit of local government pursuant to Article VII, Section 6 (a) of the 1970 Constitution of the State of Illinois and, as such, may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, the City Council of the City of Chicago ("City") on September 10, 1997 approved the sale of certain lands to the highest bidder pursuant to auction conducted by the Chicago Department of General Services ("DGS"); and

WHEREAS, the highest bidder was awarded, and proceeded to successfully pay compensation to the City in the amount of \$55,300.00 as acknowledged by DGS in Exhibit B; and

WHEREAS, the area auctioned and sold was in actuality right of way awaiting construction for the widening of W. Pershing Road by the Chicago Department of Transportation ("CDOT"); and

WHEREAS, CDOT eventually elected not to widen W. Pershing Road as planned;  
and

WHEREAS, the successor owner of the auctioned parcel is Lakeside Bank, an Illinois banking corporation ("Developer"); and

WHEREAS, the Developer proposes to use the portion of the street remnant to be vacated herein for construction of a bank branch building with an accessory on-site drive-through as originally approved by the Zoning Board of Appeals on January 19, 2018 as Cal. No. 48-18-5; and

WHEREAS, the Developer anticipates that its request for a revision to its bank branch plan will be heard by the Zoning Board of Appeals on May 15, 2020; and

WHEREAS, both the Developer and City wish to clear the confusion in the ownership/title by vacating precisely the same right of way as was sold by the City, acting through DGS, to clearly demonstrate ownership in the Developer's name; and

WHEREAS, the City Council of the City of Chicago, after due investigation and consideration, has determined that the nature and extent of the public use and the public interest to

be subserved is such as to warrant the vacation of that portion of the public street, described in the following ordinance; now, therefore.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1.

SECTION 2. The City hereby reserves for the benefit of any currently in place public and/or quasi-public utilities (being existing members of the Chicago Office of Underground Coordination), their successors or assigns, a non-exclusive utility easement to operate, maintain, construct, replace and renew any existing overhead and/or underground equipment under, over and along the portion of the street remnant herein vacated, with the right of ingress and egress at all times. The grade of the vacated portion of the public way shall not be altered in a manner so as to interfere with the operation and maintenance of said facilities. No construction, buildings, permanent structures or obstructions shall occur or be placed over the area herein vacated without express written release of easement by the involved utility(ies). Any future Developer-prompted relocation of facilities lying within the area herein vacated will be accomplished by the involved utility, and be done at the expense of the Developer, its successors or assigns.

SECTION 3. The vacation herein provided for is made under the express condition that the Developer and its successors and assigns, shall hold harmless, indemnify and defend the City of Chicago from all claims related to said vacation.

SECTION 4. The vacation herein provided for is made upon the express condition that within one hundred eighty (180) days after the passage of this ordinance, the Developer shall file or cause to be filed for recordation with the Office of the Recorder of Deeds of Cook County, Illinois a certified copy of this ordinance, together with the associated full-sized plats as approved by the City's Superintendent of Maps and Plats.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication. The vacation shall take effect and be in force from and after recording of the approved ordinance and plat.
