



(1) Awning(s) projecting over the public right-of-way adjacent to its premises known as 7428 W. Belmont Said. Awning(s) at VV, Belmont Avenue measure(s): ! One (1) at twenty-four point six seven. (24.67) feet in length, and two pointthree three (2.33) feetiin width for of-fifty-seven point four eight (57.48) square feet. The location of said privilege shall be as shown on prints kept on file with-the Department of Business Affairs and Consumer Protection and the Office of the City Clerk. I Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department-Signs. This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions. bf the Municipal Code of Chicago.! The grantee shall payty the City of Chicago as compensation for the privilege;#1144931 herein granted the sum of fifty (\$50.00) per annum in advance. A 25% penalty will be added for .payments received after due date. j The permit holder agrees .to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage; relocation or removal of private property caused by the City performing work in thepublic way.
