## TO THE HONORABLE, THE CITY COUNCIL OF THE CITY OF CHICAGO

Ladies and Gentlemen:

At the request of the Commissioner of Planning and Development, I transmit herewith an ordinance authorizing an amendment to a previously passed negotiated sale with Ultimate Gas and Mini-Mart for property located at 4237 South Wells and 224 West 43<sup>rd</sup> Street.

Your favorable consideration of this ordinance will be appreciated.

## ORDINANCE

WHEREAS, the City conveyed the real property located at 4237-41 South Wells Street and 224 West 43<sup>rd</sup> Street (the "City Property") to Ultimate Gas & Mini Mart, Inc., an Illinois corporation ("Corporation") pursuant to (1) an ordinance adopted by the City Council of the City (the "City Council") on May 28, 2014 and published at pages 81798 through 81838 of the Journal of Proceedings of the City Council of the City of Chicago (the "Journal") for such date (the "Project Ordinance"), (2) that certain Agreement for the Sale and Redevelopment of Land among the City, the Corporation and Issak H. Sughayar, individual sole beneficiary ("Beneficiary," together with the Corporation, the "Developer") under that certain land trust established with Chicago Title Land Trust Company pursuant to that certain Trust Agreement dated November 27, 2007 and

known as Trust Number 8002349794 ("Trust"), dated July 31, 2014 and recorded in the Office of the Recorder of Deeds of Cook County (the "Recorder's Office") on August 5, 2014 as document 1421718037 (the "Agreement"), and (3) that certain Quitclaim Deed from the City to the. Corporation dated July 31, 2014 and recorded in the Recorder's Office on August 12, 2014 as document 1422435010; and

WHEREAS, as contemplated by the Agreement, the Corporation subsequently conveyed the City Property into the Trust pursuant to that certain Deed in Trust-Quitclaim dated July 31, 2014 and recorded in the Recorder's Office on August 18, 2014 as document 1423022007, and the Trust, in turn, leased the City Property back to the Corporation pursuant to a lease agreement; and

WHEREAS, the project for which the City conveyed the City Property to the Corporation (the "Project") was defined generally in the Project Ordinance and specifically in the Agreement as the construction of two one-story, 6,100 square foot commercial buildings, one of which will contain retail tenant space and a laundromat and one of which will contain a car wash, together with parking for nineteen vehicles; and

WHEREAS, the Developer has proposed to redefine the Project as the construction of one two-story retail building with one dwelling unit and a separate car wash building; and

WHEREAS, the City and the Developer now wish to amend the Agreement to so redefine the Project and to make certain other related changes; now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. The foregoing recitals are hereby adopted as the findings of the City Council.

SECTION 2. The Commissioner of the Department of Planning and Development (the "Commissioner") or a designee of the Commissioner is each hereby authorized, with the approval of the City's Corporation Counsel, to negotiate, execute and deliver an amendment to the Agreement in substantially the form attached as an exhibit hereto (the "Amendment"), and such other supporting documents as may be necessary or appropriate to carry out and comply with the provisions of the Amendment, with such changes, deletions and insertions as shall be approved by the persons executing the Amendment and such other supporting documents.

SECTION 3. If any provision of this ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such provision shall not affect any of the other provisions of this ordinance.

SECTION 4. All ordinances, resolutions, motions or orders in conflict with this ordinance are hereby repealed to the extent of such conflict.

SECTION 5. This ordinance shall take effect immediately upon its passage and approval.

## AMENDMENT TO AGREEMENT FOR THE SALE AND REDEVELOPMENT OF LAND

This Amendment to Agreement for the Sale and Redevelopment of Land (this "Amendment") is made and entered into as of the day of , 2020 (the "Effective Date") by and among the City of Chicago, Illinois (the "City'), acting by and through its Department of Planning and Development ("DPD"), Ultimate Gas & Mini Mart, Inc., an Illinois corporation ("Corporation"), whose offices are located at 4240-58 South Wentworth Avenue, Chicago, Illinois 60609, and Issak H. Sughayar, individual sole beneficiary ("Beneficiary," together with the Corporation, the "Developer") under that certain land trust established with Chicago Title Land Trust Company pursuant to that certain Trust Agreement dated November 27, 2007 and known as Trust Number 8002349794 ("Trust"), the trustee of which has acknowledged and consented hereto by its signature below.

## RECITALS

WHEREAS, the City conveyed the real property located at 4237-41 South Wells Street and 224 West 43<sup>rd</sup> Street and described on Exhibit A hereto (the "City Property") to the Corporation pursuant to an ordinance adopted by the City Council of the City (the "City Council") on May 28, 2014 and published at pages 81798 through 81838 of the Journal of Proceedings of the City Council of the City of Chicago (the "Journal") for such date (the "Project Ordinance"), that certain Agreement for the Sale and Redevelopment of Land between the

City and the Developer dated July 31, 2014 and recorded in the Office of the Recorder of Deeds of Cook County (the "Recorder's Office") on August 5, 2014 as document 1421718037 (the "Agreement"), and that certain Quitclaim Deed from the City to the Corporation dated July 31, 2014 and recorded in the Recorder's Office on August 12, 2014 as document 1422435010 (together with the Agreement, the "City Documents"); and

WHEREAS, as contemplated by the Agreement, the Corporation subsequently conveyed the City Property into the Trust pursuant to that certain Deed in Trust-Quitclaim dated July 31, 2014 and recorded in the Recorder's Office on August 18, 2014 as document 1423022007, and the Trust, in turn, leased the City Property back to the Corporation pursuant to a lease agreement (the "Lease Agreement"); and

WHEREAS, the project for which the City conveyed the City Property to the Corporation (the "Project") was defined generally in the Project Ordinance and specifically in the Agreement as the construction of two one-story, 6,100 square foot commercial buildings, one of which will contain retail tenant space and a laundromat and one of which will contain a car wash, together with parking for nineteen vehicles; and

WHEREAS, the Developer has proposed to redefine the Project as the construction of one two-story retail building with one dwelling unit and a separate car wash building; and

WHEREAS, the parties hereto now wish to amend the Agreement to so redefine the Project and to make certain other related changes.

NOW, THEREFORE, in consideration of the mutual covenants and agreements contained herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and pursuant to an ordinance adopted by the City Council on

, 2020, and published at pages through of the Journal for such date, the parties hereto hereby agree as follows:

## AGREEMENTS

- 1. Incorporation of Recitals. The foregoing recitals are incorporated into this Amendment by reference and constitute a material part hereof.
- 2. No Effect on Recording Priority. The parties agree that entering into this Amendment shall have no effect on the recording priority of the City Documents and that this Amendment

shall relate back to the dates that the City Documents were originally recorded in the Recorder's Office.

- 3. The definition of the Project in Section 2 of the Agreement is hereby amended to be redefined as set forth in the recitals above.
- 4. As contemplated by Sections 8 and 11.1 of the Agreement, the Developer has submitted to DPD all necessary building permits for the Project as redefined hereby prior to the Effective Date hereof.
- 5. The amount of the Preliminary Project Budget set forth in Section 9 of the Agreement is hereby increased

from \$822,000 to [\$2,059,999].

- 6. As contemplated by Sections 9 and 10.2 of the Agreement, the Developer has submitted to DPD, and DPD has approved, a Budget and Proof of Financing for the Project as redefined hereby prior to the Effective Date hereof.
- The Plans for the Project defined in Section 11.2 of and attached as Exhibit C to the Agreement are hereby replaced by the Plans dated [ ] attached hereto as Exhibit C.
- 8. The Project commencement and completion dates set forth in Section ,13 of the Agreement are hereby extended from October 31, 2015 to [March 31, 2021] and October 31, 2016 to [September 30, 2022], respectively.
- 9. The Developer's request for a Certificate of Completion pursuant to Section 14 of the Agreement shall include written evidence of the inspection and approval by the City's Department of Transportation of the new east-west public alley north of the City Property completed by the Developer pursuant to and an ordinance adopted by the City Council on November 5, 2014 (0214-6861, recorded in the Recorder's Office on April 15, 2015 as document 1510529062).
- 10. The contract participation rates for minority-owned businesses and women-owned businesses set forth in Section 24.3(a) of the Agreement are hereby increased from at least 24% to at least 26% and from at least 4% to at least 6%, respectively.
- 11. The Developer has held a pre-construction conference or meeting with DPD monitoring staff as described in Section 24.4 of the Agreement prior to the Effective Date hereof.
- 12. The Trust Agreement attached to the Agreement as Exhibit D is hereby replaced by the current Trust Agreement attached hereto as Exhibit D.
- 13. The Lease Agreement for the City Property between the Trust and the Corporation attached to the Agreement as Exhibit E is hereby replaced by the current Lease Agreement attached hereto as Exhibit E.
- 14. No Change in Defined Terms. All capitalized terms not otherwise defined herein, shall have the same meanings as set forth in the City Documents.

- 15. Other Terms in the City Documents Remain. Except as revised herein, all other provisions and terms of the City Documents shall remain unchanged.
- 16. Authority. Developer represents and warrants to the City that this Amendment is duly authorized by all necessary corporate or limited liability company action and that the person executing this Amendment on behalf of such party is duly authorized to execute this Amendment on behalf of such party.
- 17. Recording and Filing. Developer shall cause this Amendment and all amendments and supplements hereto to be recorded and filed against the City Property within fifteen (15) business days of the date hereof in the Recorder's Office. Developer shall pay all fees and charges incurred in connection with any such

recording. Upon recording, Developer shall immediately transmit to the City an executed original ofthis Amendment showing the date and recording number of record.

18. Counterparts. This Amendment may be executed in counterparts, each of which shall be deemed an original, and all of which, when taken together, shall constitute a single agreement.
