# ORDINANCE

## */r ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:*

SECTION I. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by

changing all the M2-3 Light Industry District symbols and indications as shown on Map No. 3-G in the area

bounded by

Beginning at West North Avenue; a line 144 feet west of and parallel to North Throop Street; the alley next south of and parallel to West North Avenue; North Elston Avenue; a line 80 feet south of and parallel to West North Avenue; a line from a point 80 feet south of West North Avenue and 17 feet east of North Elston Avenue, to a point 72.25 feet south of West North Avenue and 18.44 feet northeast of North Elston Avenue; a line from a point 72.25 feet south of West North of West North Avenue and 18.44 feet northeast of North Elston Avenue; a line from a point 72.25 feet south of West North Avenue and 18.44 feet northeast of North Elston Avenue; to a point 48.08 feet south of West North Avenue and 288 feet West of North Throop Street; a line 288 feet west of and parallel to North Throop Street (running north to the point of beginning),

to those of a C2-3 Motor Vehicle-Related Commercial District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
