SECTION 1. Title 17 of the Municipal Code of Chicago Zoning Ordinance, is hereby amend by changed all of llie Bl-1 Neighborhood Shopping District Symbols and indications as shown on map No. 8-G in the area bounded by The alley next north of and parallel to West 35th Street; a line 222 feet east of and parallel to South Lituanica Avenue; West 3 5th Street; and the alley next east of an parallel to South Lituanica Avenue
