ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the Bl-1 Neighboorhood Shopping District symbols and indications as shown on Map No. 17-1 in the area bounded by

The alley next north of and parallel to West Pratt Boulevard; a line 186.24 feet east of and parallel to North Washtenaw Avenue; West Pratt Boulevard; a line 136.24 feet east of and parallel to North Washtenaw Avenue

to those of a RT-4 Residential Two-Flat, Townhouse, and Multi-Unit District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and approval.


