ORDINANCE

BE IT ORDAINED BT THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. That the Chicago Zoning Ordinance be amended by changing all of the M3-3 Heavy Industry Distric symbols and indications as shown on iMap 5-G in the area bounded by:

A lincl 50 feet southeasterly of and parallel to West Wabansia Avenue; the alley northeasterly of and parallel to North Elston Avenue; a line 275 feet southeasterly of and parallel to West Wabansia Avenue; and North Elston Avenue

To those of a C3-3 Commercial, Manufacturing and Employment District.

SECTION 2. This Ordinance shall be in force and effect from and after its passage and publication.
