SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby . amended by changing all of the RS-3 Residential Single-Unit (detached house) District symbols and indications as shown on Map No. 9-1 in the area bounded by

A line 75 feet south of and parallel to West Cornelia Ave; the alley next east of and parallel to North Albany Avenue; a Line 147 feet South Easterly of West Cornelia Avenue as measured along the intersection of North Albany Ave and West Cornelia perpendicular there to; And North Albany Avenue.
