BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RT-4, Residential Two-Flat, tqwnhouse and Multi-Unit District symbols and indications as shown on Map No. 4-1 in an area bound by

The public alley next north of and parallel to West 21st Place,' a line 96 feet east of and parallel to South Washtenaw Avenue; West 21^{sl} Place,' And a line 72 feet east of and parallel to South Washetnaw Avenue

to those of a RM-4.5 Residential Multi-Unit District.

SECTION 2. This ordinance takes effect after its passage and due publication.
