A line 186.6 feet south of and parallel to West Hollywood Avenue; the public alley next east of and parallel to North Artesian Avenue; a line 216.6 feet south of and parallel to West Hollywood Avenue; North Artesian Avenue

to those of a RM-4.5 Residential Multi-Unit District.
