ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RM5 Residential Multi-Unit District symbols and indications as shown on Map No. 10-E in the area bounded by

the alley next north of and parallel to East 43^{rd} Street; South Calumet Street; East 43^{rd} Street; and the alley next west of and parallel to South Calumet Avenue

to those of a B3-2 Community Shopping District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

Street in Chicago, Illinois to establish retail, restaurant, and other culinary uses, which may include a book store, art gallery, music school, meeting venue, banquet facility and entertainment including venue, performances. The subject property is adjacent to an existing CTA Green Line station and is served by existing CTA bus service and will, thus, satisfy the Transit Served Location Criteria.


