ORDINANCE

WHEREAS, the City of Chicago (the "City") is a home rule unit of government under Section 6(a), Article VII of the 1970 Constitution of the State of Illinois and as such may legislate as to matters that pertain to its local government and affairs; and

WHEREAS, the City has determined that the continuance of a shortage of affordable housing for persons of low and moderate income is harmful to the health, prosperity, economic stability and general welfare of the City; and

WHEREAS, the City, pursuant to the HOME Investment Partnerships Program ("HOME Program"), received from the United States Department of Housing and Urban Development an allocation of funds ("HOME Funds") to make loans

and grants to expand the long-term supply of affordable housing through, among other things, acquisition, new construction, reconstruction and moderate and substantial rehabilitation in low- and moderate-income areas; , and

WHEREAS, the City Council ofthe City (the "City Council"), pursuant to an ordinance (the "Original Ordinance") enacted on November 13, 2002, and published at pages 96843- 97110 of the Journal of the Proceedings of the City Council (the "Journal") of that date, authorized the City's Department of Housing ("DOH"), among other things, to provide HOME Funds to finance a portion of the costs for the acquisition and construction of a senior citizen residential facility consisting of a building containing approximately 126 units located at 3440 West Roosevelt Road in Chicago Illinois (the "Property") in the amount of \$5,623,000; and

WHEREAS, as of March 1, 2004, the City made a loan of HOME Funds in the principal amount of \$5,623,000, with an interest rate of zero (0%) percent per annum and a term not to exceed forty-two (42) years (the "Loan"), to Roosevelt Tower-I, LLC, an Illinois limited liability company (the "Borrower") of which the original managing member was Boulevard Realty Services Corp., an Illinois corporation ("Boulevard"); and

WHEREAS, the Loan was secured by, among other things, that certain Junior Mortgage, Security Agreement and Financing Statement dated as of March 1, 2004, made by the Borrower in favor of the City (the "Mortgage"); and

WHEREAS, the City Council, pursuant to an ordinance enacted on June 28, 2006, and published at pages 78471 -78475 ofthe Journal of that date, authorized East Lake/Roosevelt I, LLC, an Illinois limited liability company ("East Lake") to assume the managing membership interest ofthe Borrower then held by Boulevard and as such East Lake became, and is now, the sole managing member of the Borrower; and

WHEREAS, the Mortgage is subordinate to that certain mortgage dated as of March 1, 2004 made by the Borrower in'favor of PFC Corporation, a Delaware corporation, (the "Senior Lender"), securing a loan in the amount of \$7,230,000.00 (the "Senior Loan") that was insured by the Federal Housing Administration ("FHA"); and

WHEREAS, the Borrower desires to refinance the Senior Loan and to execute a new mortgage in connection with the Property in favor of the Senior Lender or with any other financial institution that is acceptable to the Commissioner of DOH (as defined below) (the "New

First Mortgage") with a new loan that has a lower interest rate and is insured by FHA pursuant to Section 223 (a)(7) of the National Housing Act, and has requested that the City approve a proposed restructuring of the Loan; and

WHEREAS, DOH desires to approve a restructuring (the "Restructuring") ofthe Loan in a manner that (1) will not alter the principal balance of the Loan, (2) will not alter the interest rate on the principal balance ofthe Loan (3) will extend the maturity date ofthe Loan, and (4) will subordinate the lien of the mortgage for the Loan to the lien of the New First Mortgage as approved by the Commissioner of DOH (the "Material Terms"); now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. The above recitals are expressly incorporated in and made a part of this ordinance as though fully set forth herein.

SECTION 2. The Restructuring is hereby approved as described above. The Commissioner of DOH (the "Commissioner of DOH") or a designee of the Commissioner of DOH (each, an "Authorized Officer") are each hereby authorized, subject to approval by the Corporation Counsel, to enter, into and execute such agreements and instruments and perform any and all acts as shall be necessary or advisable in connection with the implementation of the Restructuring. Each Authorized Officer is hereby authorized, subject to approval

by the Corporation Counsel, to enter into and execute such agreements and instruments and perform any and all acts as shall be necessary or advisable in connection with any future restructuring of the Loan that does not substantially modify the Material Terms.

SECTION 3. Notwithstanding anything to the contrary contained in the Municipal Code of Chicago (the "Municipal Code") or any other ordinance or mayoral executive order, no parties other than the owners of the Property as of the date following the date of the closing of the Restructuring (collectively, the "Owner"), any legal entities that are direct owners in excess of 7.5% of the Owner that changed in connection with the Restructuring, and all legal entities that constitute the direct or indirect controlling parties of the Owner (as determined by the Corporation Counsel), shall be required to provide to the City the document commonly known as the "Economic Disclosure Statement and Affidavit" (or any successor to such document) in connection with the Restructuring.

SECTION 4. To the extent that any ordinance, resolution, rule, order or provision of the Municipal Code, or part thereof, is in conflict with the provisions of this ordinance, the provisions of this ordinance shall control. If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity of such section, paragraph, clause or provision shall not affect any of the other provisions of this ordinance.

SECTION 5. This ordinance shall be effective as of the date of its passage and approval.




