ORDINANCE

STOCK8RIDGE 600 WEST JACKSON, LLC Acct. No.: 459634 -1
Permit No: BACP1147911

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to STOCKBRIDGE 600 WEST JACKSON, LLC upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use two (2) Vault(s) under the public right-of-way adjacent to its premises known as 600 W JACKSON BLVD.

Said Vault(s) at W. JACKSON BLVD measure(s):

One (1) at one hundred forty-one point two six (141.26) feet in length and fifteen point five (15.5) feet in width for a total of two thousand one hundred eighty-nine point five three (2,189.53) square feet.

Said Vault(s) at JEFFERSON measure(s):

One (1) at ninety-eight point eight three (98.83) feet in length and eight point four two (8.42) feet in width for a total of eight hundred thirty-two point one five (832.15) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #BACP1147911 herein granted the sum of two thousand nine hundred fifty-four (\$2,954.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.
Authority herein given and granted for a period of five (5) years from and after 07/08/2020.
