ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1 Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of C1-2 Neighborhood Commercial District symbols and indications as shown on Map No. 4-H in the area bounded by:

The public alley next north of and parallel to West 21st Street; a line 300 feet West of and parallel to South Wolcott Avenue; West 21st Street; a line 325 feet West of and parallel to South Wolcott Avenue.

to those of a B2-3 Neighborhood Mixed Use District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
