ORDINANCE

BE IT ORDAINED BY THE CI TY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS-3 Residential Single-Unit Detached House District symbols and indications as shown on Map No.7-L in the area bounded by:

The alley next north of and parallel to west Barry Avenue; a line 317.85 feet west of and parallel to North Cicero Avenue; west Barry Avenue; and a line 347.85 feet west of and parallel to North Cicero Avenue.
