SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS-3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map Noi 1 -I in an area bound by

The public alley next south of and parallel to West Huron Street; North Talman Avenue; a line 124 feet south of and parallel to West Huron Street; And the public alley next west of and parallel to North Talman Avenue

to those of a RT-4 Residential Two-Flat, Townhouse and Multi-Unit District. SECTION 2. This ordinance takes effect after its passage and due publication.
