ORDINANCE

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to LAKEVIEW CHAMBER OF COMMERCE upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use two (2) Planter(s) on the public right-of-way for beautification purposes adjacent to its premises known as 3100 - 3120 N LINCOLN AVE.

Said Planter(s) at 3100 N. Lincoln Avenue, measure(s):

One (1) at four point one seven (4.17) feet in length and Zero (0) feet in width for a total of four point one seven (4.17) square feet.

Said Planter(s) at 3120 N. Lincoln Avenue measure(s):

One (1) at ten point five (10.5) feet in length and Zero (0) feet in width for a total of ten point five (10.5) square feet.

Grantee must allow the required clear and unobstructed space for pedestrian passage at all times per rules and regulations approved by the Department of Transportation.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

The grantee shall pay to the City of Chicago as compensation for the privilege #BACP1619138 herein granted the sum of Zero (\$0.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after 06/17/2020.
