ORDINANCE

REGAL CINEMAS CITY NORTH Acct. No.: 353500 - 1

Permit No: BACP1551654

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to REGAL CINEMAS CITY NORTH upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, two (2) Canopy with Lettering or Graphics(s) projecting over the public right-of-way adjacent to its premises known as 2600 N WESTERN AVE.

Said Canopy with Lettering or Graphics(s) at N. Western rriensure(s):

One (i) at sixty-five point four seven (65.47) feet in length and Zero (0) feet in width for a total of sixty-five point four seven (65.47) square feet.

One (1) at one hundred fifty-six (156) feet in length and Zero (0) feet in width for a total of one hundred fifty-six (156) square feet.

The location of said privilege shall be as'shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege.shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #BACP1551654 herein granted the sum of two hundred seventy-one point four seven (\$271.47) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees-tb hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage; relocation or removal of private property^ caused; by the ,City performing'^work ih^tlie^public way.

Authority herein given and granted for a period'of five (5) years from and after 03/09/2021.
