#### ORDINANCE -Dfc-C- \5, ^

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS-3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 20-H in the area bounded by

A line 120.70 feet south of and parallel to West 86<sup>th</sup> Street; the alley next east of

and parallel to South Marshfield Avenue; a line 154.03 feet south of and parallel

to West 86<sup>th</sup> Street; And South Marshfield Avenue.

to those of a RT-3.5 Residential Two-Flat, Townhouse and Multi-Unit District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
