# SUBDIVISION ORDINANCE

Be it Ordained by the City Council of the City of Chicago:

SECTION 1. The Commissioner of the Chicago Department of Transportation, or any of her designees, is each hereby authorized and directed to approve a proposed Forty Four Commons Resubdivision, being a resubdivision of certain lots owned by Grand Boulevard Terraces, LLC ("Developer") in the block bounded by S. State Street, S. Wabash Avenue, E. 44<sup>th</sup> Street and E. 45<sup>th</sup> Street and legally described in the attached Plat of Resubdivision (Exhibit A, CDOT File: 03-03-21-3997), which, for greater certainty, is hereby made a part of this ordinance.

SECTION 2. The Commissioner of the Chicago Department of Transportation, is hereby authorized and directed to approve a dedication of certain property owned by the Developer in the block identified in Section 1, and legally described in Exhibit A. The Developer shall, at its sole expense, construct an alley on the to-be-dedicated property. The dedication is accepted upon the express condition that such alley be constructed according to the current version of the Chicago Department of Transportation's Regulations for Opening, Repair and Construction in the Public Way and its appendices, and as agreed to by the Developer in the Duty to Build Agreement, hereby attached as Exhibit C and made a part of this ordinance.

SECTION 3. A small opening of public land is also required, by and through the authority of the Department of Planning and Development, to complete the public alley on the subject block, such Plat of Opening being also hereby made part of this ordinance as Exhibit B. The improvement of said land with standard surface, and public lighting shall be completed at the sole expense of the Developer in compliance with the current version of the Chicago Department of Transportation's Regulations for Opening, Repair and Construction in the Public Way and its appendices, and as approved by, the CDOT Division of Electrical Operations.

SECTION 4. The resubdivision herein provided for is made upon the express condition that within 180 days after the passage of this ordinance, and prior to recording, the Developer shall deposit in the City Treasury of the City of Chicago, a quoted security deposit sufficient to defray the costs of work to constructing the alley, public paving, curb, and related appurtenances. The Developer shall construct said work in the newly dedicated and opened public alleys in accordance with the most current version of the Chicago Department of Transportation's Regulations for Opening, Repair and Construction in the Public Way and its appendices, and in accordance with the executed Duty to Build Agreement (Exhibit C), prior to return of the security deposit.

SECTION 5. The Developer acknowledges that any private sewers and connections, or any other private

appurtenances within the area to be dedicated shall be

sealed, removed or relocated to private property at the Developer's expense, in accordance with the standard procedures of the Department of Water Management, Sewer Section, or established as public through separate City Council action. In the event that any sewer is abandoned, the abandonment plans must be reviewed, approved and permitted by the Department of Water Management, Sewer Design Section, prior to work. The Developer understands that it is Developer's responsibility to provide proper drainage, and lay new sewer main and associated structures, at Developer's sole expense in the alley herein dedicated, in accordance with plans reviewed, approved and permitted by the Department of Water Management Sewer Design Section, prior to work. Acceptance of new sewers is contingent upon submittal of as-built drawings, and physical and videotape inspection provided by the Developer to the Department of Water Management within 30 days of completion. All sewer work in both the public way and on private property requires permit of a Licensed Drainlayer as secured through the Department of Buildings, Sewer Permit Section.

SECTION 6. The resubdivision herein provided for is made under the express condition that the Developer, its successors and assigns, shall hold harmless, indemnify and defend the City of Chicago from all claims related to the resubdivision.

SECTION 7. The resubdivision herein provided for is made upon the express condition that within one hundred eighty (180) days after the passage of this ordinance, the Developer shall file or cause to be filed for recordation with the Office of the Cook County Clerk / Recordings Division, a certified copy of this ordinance, together with the full-sized corresponding plat(s) approved by the Department of Transportation's Superintendent of Maps and Plats.

SECTION 8. This ordinance shall take effect and be in force from and after its passage and publication. The resubdivision shall take effect and be in force from and after the recording of the approved ordinance and associated plats.
