#### **ORDINANCE**

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1 Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of Ml-2 Limited Manufacturing/Business Parks District symbols and indications as shown on Map No. 22-F in the area bounded by:

West 89<sup>th</sup> Street; South Holland Road; a line 249.19 feet south of West 89<sup>th</sup> Street as measured along South Holland Road and per pendicular thereto; a line 60 feet west of and parallel to South Holland Road; a line 279.19 feet south of and parallel to West 89<sup>th</sup> Street; a line 211.86 feet west of and parallel to South Holland Road; And a line 143.46 feet west of South Holland Road as measured along the south line of West 89<sup>th</sup> Street and per pendicular thereto;

to those of a M2-2 Light Industry District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.




