### ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing the CI-2 Neighborhood Commercial District symbols and indications as shown on Map No. 6-1 in the area bounded by

A line 211 feet north of and parallel to West 26<sup>th</sup> Street; South Troy Street; A line 187 feet north of and parallel to West 26<sup>th</sup> Street; and the alley next west of and parallel to South Troy Street.

to those of a RT-4 Residential Two-Flat Townhouse and Multi-Unit District
