# **ORDINANCE**

# BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the Ml-1, Limited Manufacturing/Business Park District symbols and indications as shown on Map No. 28-A in the area bounded by

A line 200 feet south of and parallel to East 118th Street; a line 385 feet east of and parallel to South Avenue O; a line 499.70 feet south of and parallel to East 118th Street; and South Avenue O

to those of a M2-1, Light Industry District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
