ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all B2-3 Neighborhood Mixed-Use District symbols and indications as shown on Map No. 7-J in the area bounded by

The public alley north next of and parallel to North Milwaukee Avenue; North Allen Avenue; North Milwaukee Avenue; A line 39.80 feet west of and parallel to North Allen Avenue; a line 91.84 feet north of and running on a northwesterly line for 5.63 feet; a line 99.13 feet north of and parallel to Milwaukee Avenue; A line 53.50 west of and parallel to North Allen Avenue

to those of a C1-3 District Neighborhood Commercial District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
