ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the Bl-1 Neighborhood Shopping District symbols and indications as shown on Map No. 5-M in the area bounded by

The alley north of and parallel to West North Avenue, a line 131.92 feet west of and parallel to North Melvina Avenue; West North Avenue; and a line 156.92 feet west of and parallel to North Melvina Avenue,

to those of a B3-1 Community Shopping District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
