ORDINANCE

BE IT ORDAINED B Y THE CITY COUNCIL OF THE CITY OF CHICA GO:

SECTION 1. Title 17 of the Municipal Code, the Chicago Zoning Ordinance, be amended by changing all the RS-3 Single Unit (Detached House) District symbols and indications as shown on Map No. 5-L in the area bound by

a line 133 feet north of and parallel to West St. Paul Avenue; North LeClaire Avenue; a line 83 feel tiotlh of and paiallel lo West St. Paul Avenue, and the alley next west of and parallel to North LeClaire Avenue,

to those of a RM-4.5 Residential Multi-Unit District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
