#### **ORDINANCE**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of Bl-1 Neighborhood Shopping District symbols and indications as shown on Map No. 13-H in the area bounded by

A line 58.17 feet north of and parallel to West Balmoral Avenue; the public alley next East of and parallel to North Ravenswood Avenue; West Balmoral Avenue; and North Ravenswood Avenue.






