# ORDINANCE

# fl£ 77 ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code, the Chicago Zoning Ordinance,

be amended by changing all the B3-1 Community Shopping District

symbols and indications as shown on Map No.9-M in the area bounded by

West Cornelia Avenue; North Central Avenue; a line 206.80 feet south of and parallel to North Cornelia Avenue; and Public Alley west of and parallel to North Central Avenue;

to those of a B2-2 Neighborhood Mixed-Use District is hereby established in the

area above described.
