#### **ORDINANCE**

#### TT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 ofthe Municipal Code of Chicago - the Chicago Zoning

Ordinance, be amended by changing all the B3-I Community Shopping District symbols and

indications as shown on Map No. 7-M in the area bounded by

West Diversey Avenue; North Meade Avenue; the alley next south of and parallel to West Diversey Avenue; and a line 57.36 fect west of and parallel to North Meade Avenue,

to those of a B3-3 Community Shopping District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
