### ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION I. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the BI-1 Neighborhood Shopping District symbols and indications as shown on Map No. 16-1 in the area bounded by

WEST 63RD STREET; A LINE 75 FEET EAST OF AND PARALLEL TO SOUTH ALBANY AVENUE; THE ALLEY NEXT SOUTH OF AND PARALLEL TO 63RD STREET; AND SOUTH ALBANY AVENUE.
