Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the M1-2 Limited Manufacturing / Business Park District symbols and indications as shown on Map No. 7-H in the area bounded by

a line 400 feet southeast of and parallel to North Terra Cotta Place; the alley next northeast of and parallel to North Clybourn Avenue; a line 425 feet southeast of and parallel to North Terra Cotta Place; and North Clybourn Avenue,

to those of a RM-4.5 Residential Multi-Unit District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
