BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the M1 -2 Limited Manufacturing/Business Park District symbols and indications as shown on Map No. 7-H in the area bounded by

The public alley next south of and parallel to West Wrightwood Avenue; the public alley next northeast of and parallel to West Altgeld Street; a line 160 feet southeast of the south line of the public alley next south of and parallel to West Wrightwood Avenue (as measured along the northeast line of West Altgeld Street); West Altgeld Street,

to those of an RS3 Residential Single-Unit (Detached House) District.

SECTION 2. This ordinance takes effect after its passage and approval.
