BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the MI-1 Limited Manufacturing / Business Park District symbols and indications as shown on Map No. 17-0 in the area bounded by

the alley next north of and parallel to West Devon Avenue; a line 49.94 feet east of the intersection of North Avondale Avenue and West Devon Avenue, as measured along the north right-of-way line of West Devon Avenue and perpendicular thereto; West Devon Avenue; and North Avondale Avenue, to those of a BI-1 Neighborhood Shopping District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
