## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1.

Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RT4, Residential Two-Flat, Townhouse and Multi-Unit District symbols as shown on Map No. 6-J in the area bounded by:

A line 33 feet North of and parallel to West 25th Street; South Springfield Avenue; West 25<sup>th</sup> Street; a public alley next West of and parallel to South Springfield Avenue.

To those of a B2-2, Neighborhood Mixed-Use District
