  - Proof of residency, in the form of a copy of your drivers license, state identification, or utility bills are submitted at the time of application.
- Completed application forms may be returned to: the office of your alderman, any City of Chicago Department of Revenue facility, or via mail at P.O. Box 803100. Chicago, IL 60680-3100, ATTN: Disabled Permitting Section. A \$25.00 maintenance fee will be billed to you annually.
