### **ORDINANCE**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the RS-2 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 12-N in the area bounded by

West 54<sup>th</sup> Street; the alley next east of and parallel to South Nashville Avenue; a line 96 feet south of and parallel to West 54<sup>th</sup> Street; and South Nashville Avenue,  
to those of a RS-3 residential Single-Unit (Detached House) District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
