Please be advised that on November 18, 2009, the City Council (the "City7CouneiO<sub>A</sub>pUhe City of Chicago (the "City") adopted an ordinance (the "Bond Ordinance") authorizing the issuance of (i) \$401,920,000 aggregate principal amount of General Obligation Bonds, Refunding Series 2009A (the "Series 2009A Bonds"), (ii) \$159,855,000 aggregate principal amount of General Obligation Bonds, Taxable Project and Refunding Series 2009B (the "Series 2009B Bonds"), (iii) \$98,320,000 aggregate principal amount of General Obligation Bonds, Taxable Project Series 2009C (Build America Bonds - Direct Payment) (the "Series 2009C Bonds"), and (iv) \$133,180,000 aggregate principal amount of General Obligation Bonds, Taxable Project Series 2009D

(Recovery Zone Economic Development Bonds - Direct Payment) (the "Series 2009D Bonds" and, together with the Series 2009A Bonds, the Series 2009B Bonds and the Series 2009C Bonds, the "Bonds"), and also providing for the levy and collection of a direct annual tax on all taxable property within the City for the payment of the principal of and interest on the Bonds as the same become due.

You are further advised that a copy of the Bond Ordinance, certified by the City Clerk of the City, was filed in each of your offices, on January 26, 2010 with the County Clerk of the County of Cook and on January 26, 2010 with the County Clerk of the County of DuPage, and the Bond Ordinance is in full force and effect. Copies of filing certificates of the Bond Ordinance with your respective offices are attached hereto as Exhibit I. You are further advised that the Bonds were issued on January 27, 2010. The amount of the annual tax levy requirements for the payment of the principal of and interest on the Bonds resulting from the sale of the Bonds and from the application to the payment of interest on the Bonds, of (i) \$17,553,848.64 of L.C. Proceeds (as defined in that certain ordinance approved by the City Council on June 3, 2009 authorizing the appropriation of termination proceeds from the Concession and Lease Agreement of Chicago Midway International Airport (the "MDW Ordinance ")) as provided under Section 1 (ii) of the MDW Ordinance, and (ii) \$5^46Ci,7\$8j0'0 of ^ subsidy payments received by the City with respect to the Bonds, will be less^TMarK^he^levy^of taxes authorized in Section 7 of the Bond Ordinance; therefore, I haKelCdefe^mined that a reduction in the amount of the tax levy in the years 2010 to 2038, inclusive, is deemed desirable in connection with the sale of the Bonds.

YOU ARE THEREFORE ORDERED AND DIRECTED to abate from the taxes levied in Section 7 of the Bond Ordinance that amount representing the reduction in the amount of taxes levied by the City resulting from the sale of the Bonds and the application of other moneys for the payment of the principal of and interest on the Bonds as described above, the amount of such abatement and the remainder of such taxes so levied which are to be extended for collection being as follows:
