ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B1-1, Neighborhood Shopping District symbols and indications as shown on Map No. 5-J in the area bounded by

North Pulaski Avenue; W. Wabansia Avenue; the public alley next east of North Pulaski Avenue; and a line 112.03 south of W. Wabansia Avenue

to those of a B3-1 Community Shopping District.

SECTION 2. This ordinance takes effect after its passage and approval.

In accordance with Section 11.10-3 of the Zoning Ordinance, Title 17 of the Municipal Code of Chicago, please be informed that on or about June 1, 2011, Plaza Popular, LLC will file an application with the Department of Housing and Economic Development of the City of Chicago for a change in zoning from Bl-1, Neighborhood Shopping District to a B3-1 Community Shopping District for the property commonly known as 1649-57 North Pulaski Avenue (the "Property").

The Property currently features a one story, approximately 6,000 square foot retail center with 20 parking spaces. Plaza Popular has leased 4,600 square feet of the retail center to a Laundromat. The present zoning does not permit a Laundromat, and therefore Plaza Popular seeks to amend the zoning designation to B3-1 which permits a Laundromat.
