ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RT3.5, Residential Two-Flat, Townhouse and Multi-Family District symbols and indications as shown on Map No. 9-G in the area bounded

A line 24.02 feet south of West Grace Street; the north-south public alley next east of and parallel to North Janssen Avenue; a line 49.02 feet south of West Grace Street; and North Janssen Avenue to those of a RT4, Residential Two-Flat, Townhouse and Multi-Family District.

Section 2. This ordinance takes effect after its passage and approval.
